Motion by Mrs. Hendrickson to recess the regular Town of Bethel Town Board Meeting and open the public hearing. Seconded by Mr. Cohen, put to a vote and carried 5-0. Ms. Sheehan, Town of Bethel, Town Clerk read the public hearing notice as advertised in the Sullivan County Democrat. Mr. McEwan asked Ms. Sheehan, Town Clerk, in regards to service. Ms. Sheehan explained that the building was posted on August 1<sup>st</sup>, property owner mailed c/r/r and regular mail on 8/1, notice hand-delivered to property owner on 8/9 which he indicated he had received the 8/1 letter regular mail; as of today green card has not been received back and personal service failed.

Mr. Sturm indicated we sent out to bid; no bids were received.

Mr. McEwan, Attorney for the Town, stated the property owner is in Chapter 7 Bankruptcy. Recommending no further action. If we take any action it will violate stay. Mr. McEwan asked are we listed as creditor? Make a claim for any debt that is owed the town.

# **Road Expenditure Agreements**

Permanent improvements. The following sums shall be set aside to be expended for the permanent improvement of Town highways.

- a) On the road commencing at Sgt. Andrew Brucher Road and leading to East Sullivan (Lake Site) a distance of 1277 feet, there shall be expended not over the sum of \$13,950; type 6 base and type 7 top; width of traveled surface 14 feet; thickness 1-1/2 inches type 6 base 1 inch type 7 top; and subbase asphalt.
- b) On the road commencing at Lake Site (dead end) and leading to dead end a distance of 425 feet (East Oak), there shall be expended not over the sum of \$3,750; type 6; width of travel surface 12 feet; thickness 2 inches; subbase asphalt.
- c) On the road commencing at Lake Site 1 and leading to dead end a distance of 420 feet (East Delaware), there shall be expended not over the sum of \$3,725; type 6; width of traveled surface 12 feet; thickness 2 inches; subbase asphalt.
- d) On the road commencing at Lt. Brender Highway and leading to County Bridge Town Line a distance of .95 miles (Kortright Road), there shall be expended not over the sum of \$50,541; type 7 top, width of traveled surface 19 feet; thickness 1-1/2 inches; subbase asphalt. Also used type 6 and type 3 binder to shim and level base.
- e) On the road commencing at Woodland Way and leading to dead end of East James a distance of 295 feet there shall be expended not over the sum of

\$3,150; type 6; width of traveled surface 12 feet; thickness 2 inches; subbase asphalt and item 4-4 inches crusher run base to true and level.

f) On the road commencing at Mt. Hope Road and leading to Town of Liberty Line a distance of ¼ miles (Murphy Road), there shall be expended not over the sum of \$75,000; type #3 shim and type 7 top; width of traveled surface 19 feet; thickness 1/5 inches 7 top; subbase asphalt; type 3 binder on 1620 feet of road for base at 1.5 inches.

Motion Mrs. Simpson to approve the agreement for the expenditure of highway moneys between the Town Superintendent of the Town of Bethel and members of the Town Board. Pursuant to the provisions of Section 284 of the highway Law, we agree that moneys levied and collected in the Town for the repair and improvement of highways, and received from this State for State Aid for the repair and improvement of highways, shall be expended as stated in items a through f. Seconded by Mr. Cohen, put to a vote and carried 5-0

Dan Gettel commented that other uses need to be looked at such as adult care.

Mr. Sturm read the Order form Preliminary Injunction, Index No. 1021-2016. Town of Bethel, plaintiff, against Ronald Herbert, James F. Egan and Carol Bues a/s/a Carol Egan, defendants. They are enjoined and restrained from any activities that are in violation of the Code of the Town of Bethel including but not limited to logging, vehicle storage, junkyard use, storage of more than one unlicensed vehicle, and improper storage or disposal of any rubbish or solid waste at 52 Taconic Trail.

Motion by Mrs. Ryder to recess the regularly scheduled Town of Bethel Town Board meeting and open the scheduled 8:25 p.m. public hearing. Seconded by Mr. Cohen, put to a vote and carried 5-0. Mrs. Sheehan, Town of Bethel Town Clerk, read the legal notice as advertised in the River Reporter. Mr. McEwan asked Ms. Sheehan, Town Clerk in regards to service. Ms. Sheehan explained that the building was posted on August 2<sup>nd</sup>, property owner mailed c/r/r and regular mail on 8/1, green card has not been received back and personal service failed.

Wes Illing - I received a call today from Lazer. Owner is contacting a contractor.

Rob McEwan, Attorney for the Town, recommends keeping hearing open and to give report to Wes Illing. Town Clerk indicated she would fax to Mr. Illing tomorrow.

Larry Sietelman asked about who was responsible for the ditch between the road and the property.

Benjamin Dolson arrived late and explained he was shown the lot on Sunday. He indicated he is filling in the pond, putting flooring on foundation, mow and get Ketcham fencing. Asking 30 days. Mr. Illing said he has a contract with the property owner and what the work you are indicating to do is not going to fix the problem.

Motion by Mrs. Simpson to keep public hearing open until September 14, 2016 at 7:45 p.m. seconded by Mr. Cohen, put to a vote and carried 5-0.

# Assessment Settlement – Mayin Tohar SBL #17.-1-27.2

Per memo from Mr. McEwan, Jr., dated August 9, 2016, states the following. The issue in the special proceedings is not the value of the real property in question but the use to which it is put and whether that use is exempt from real property taxes. The Petitioner contends that the use of the property is a religious use as governed by section 420-a of the Real Property Tax Law (the "RPTL"). Mr. McEwan listed the requirements to qualify for tax exemption status under RPTL – 420-a.

Mr. McEwan's settlement proposal and recommendation is as follows:

The proposed settlement, if approved by the parties, will grant tax exempt status to the petitioner for the lot in question. In addition, the parties will enter into an order and stipulation, a copy of which is included with the memorandum, which grants the requested tax exempt status but also provides that the petitioner will waive the repayment of Town taxes paid in connection with the 2016 assessment roll.

I recommend that the Town Board approve the settlement. Consequently, I believe terms and conditions set forth in the accompanying stipulation are fair and in the best interests of the Town, which if approved by the Court will not require the Town to fully reimburse the petitioner for real property taxes paid during the course of the litigation.

Mrs. Ryder said, NYS needs to fix their tax exemption laws.

# RESOLUTION OF TOWN BOARD OF THE TOWN OF BETHEL AUTHORIZING THE SETTLEMENT OF LITIGATION AND THE EXECUTION OF A STIPULATION

**WHEREAS**, it appears that Mayin Tohar, a religious corporation, is an owner of real property located within the Town of Bethel and has commenced a special proceeding pursuant to Article 7 of the Real Tax Property Law seeking an order to obtain a real property tax exemption, based upon religious grounds, for a lot owned by it. Said lot is known on the tax map for the Town of Bethel as SBL #17.-1-27.2; and

**WHEREAS**, the Town of Bethel Board of Assessment Review and the Town Assessor have been named as respondents in the special proceeding; and

**WHEREAS**, the proper taxable status of the lot identified in the petition is the subject of the special proceeding; and

**WHEREAS**, a settlement of the litigation has been proposed and a copy of the proposed order and stipulation (the "Stipulation") has been tendered to each member of the Town Board for review and consideration; and

**WHEREAS**, the proposed settlement is summarized in a memorandum, dated August 9, 2016, which memorandum was prepared by special counsel to the Town and which recommends acceptance of the proposed terms contained in the Stipulation; and

**WHEREAS**, the Town of Bethel Town Board declares itself to be the lead agency for the purposes of any environmental review under State Environmental Quality Review Act ("SEQRA") for the action contemplated by this Resolution.

**NOW THEREFORE, BE IT RESOLVED**, that the Town Board of the Town of Bethel hereby determines that it is the best interests of the Town to accept the terms and conditions of the proposed settlement as set forth in Stipulation and upon the recommendation contained in the memorandum of special counsel referenced herein; and be it

**FURTHER RESOLVED**, the Town is authorized to settle the referenced special proceeding and enter into the Stipulation pursuant to the authority granted to it pursuant to Town Law §68(4) and special counsel is hereby authorized to sign and deliver the Stipulation and any such documents necessary to achieve settlement and to complete any remaining tasks reasonably required to complete the settlement process; and be it

**FURTHER RESOLVED**, that the implementation of the settlement is a type II action under SEQRA (6 NYCRR §617.5[20]) and no environmental review is required under SEQRA.

Motion by Town Board member Vicky Simpson, seconded by Town Board member Bernard Cohen, and adopted upon a roll call vote as follows:
