## Notice of Public Hearing - Town of Lumberland Comprehensive Plan

Motion by Mrs. Hendrickson to receive and file Town of Lumberland notice of public hearing for August 10<sup>th</sup> and lead agency status on their comprehensive plan. Seconded by Mr. Cohen, put to a vote and carried 5-0.

#### Update on Sale of a portion of real property on Ballard Road

Mr. Sturm gave an update on the sale of part of the property on Ballard Road connected to the Forest Reserve. Town has received a check in the amount of \$99,025. for the developable portion of the former Smallwood Golf Course property. It will now on the tax roll, about 38 acres but only about 15 or 18 was buildable the rest was wetlands.

The new owner is able to build one home – single family and is planning to have some farm animals. He would need Planning Board approval to subdivide if he wants more than one house. Up to two or three at the most. No plans.

So to sum up the project. The property was purchased for \$55,000 December 2011, and have invested about \$70,000 to date, for a total of \$125,000. The Town received a check for \$25,000 for doing a conservation easement to protect this 124 acre environmentally sensitive property, which is being enhanced with walking trails and other features to encourage recreational use of the property. This property is now open to all residents.

### **Correspondence – Swinging Bridge Property Owners Association**

Motion by Mrs. Simpson to receive and file a thank you letter from Swinging Bridge Property Owners' Association for the use of the Duggan facility for their annual meeting. They also made a donation of \$100 to an appropriate town organization or activity. Seconded by Mrs. Hendrickson, put to a vote 5-0. It was a consensus of the Town Board members that the appropriate organization/activity should be the youth group.

## **Road Expenditure Agreement**

An agreement between the Town Superintendent of the Town of Bethel, Sullivan County, New York and the Town of Bethel Town Board members is as follows: Pursuant to the provisions of Section 284 of the highway Law, we agree that moneys levied and collected in the Town for the repair and improvement of highways, and received from the State for State Aid for the repair and improvement of highways, shall be expended as follows:

- 1. **Permanent improvements**. The following sums shall be set aside to be expended for the permanent improvement of Town highways:
  - (a) On the road commencing at Pine Grove Rd and leading to Circle Place, a distance of 1544 feet; there shall be expended not over the of \$9,200.00; type 7 top; width of traveled surface 16 feet; thickness 1-1/2 inches; subbase asphalt type 3, binder was put in for base 300 feet at 2 inches.
  - (b) On the road commencing at Cliff Street and leading to Orange Avenue a distance of 902 feet there shall be expended not over the sum of \$5,800.00. Type 7 and type 6, width of traveled surface 14 feet; thickness 1-1/2 inches; subbase asphalt; 150 feet type 3 binder for base.
  - (c) On the road commencing at Markley Lane and leading to Pine Grove Road a distance of 1590 feet, there shall be expended not over the sum of \$12,500.00; type 6; width of traveled surface 17 feet; thickness 1/5 inches; subbase asphalt.

Motion by Mr. Cohen to the approve road expenditures as submitted. Seconded by Mrs. Hendrickson, put to a vote and carried 5-0.

## Asbestos Report Lee Cole Road – SBL#9.-1-4

Belcon Construction, LLC reported that EMSL Analytical, Inc. completed an inspection and found no asbestos. The next step is to send out bid letters for removal of structure(s). Motion by Mrs. Hendrickson to seek sealed bids for the removal of said structure(s). Seconded by Mrs. Simpson, put to a vote and carried 5-0.

## **Adopt Standard Workday Resolution**

Motion by Mrs. Hendrickson to approve for RS 2417-A, Standard Work Day and Reporting Resolution for Elected and Appointed Officials in accordance with New York State and Local Employees' Retirement System and to post for 45 days. Seconded by Mr. Cohen, put to a vote and carried 5-0.

#### **Correspondence Smallwood Civic Association**

Motion by Mr. Cohen to receive and fill e-mail from Smallwood Civic Association thanking the Town Constables and the Bethel Animal Control Officer in the capture and removal of two baby raccoons. Seconded by Mrs. Simpson and directing the Town Clerk to send the Town Constables a thank-you letter, put to a vote and carried 5-0.

### **Solar Farming Draft Local Law**

Mr. Sturm directed that a draft of Local Law No. 1 of the year 2016 regarding Solar Farming be sent to the Green Committee for review. Also, requesting that they meet by the end of the month with Rob McEwan, Attorney for the Town. Motion by Mr. Cohen the send information to the Green Committee for review. Seconded by Mrs. Ryder, put to a vote and carried 5-0.

## Request to close Silver Lake Road 7/17

Motion by Mrs. Hendrickson to approve request from Camp Chipinaw to close Silver Lake Road for visiting day on July 17, 2016 between 8 am and 5 pm. Seconded by Mrs. Simpson, put to a vote and carried 5-0.

#### Update on electronic lighted signs

Mr. Sturm has Rob McEwan, Attorney for the Town, reviewing the Town Code for Signs on State Route 17B. It does not appear to comply with that particular section of the code 345-23(o). B.J. Gettel will ask for the sign to be reviewed by the Planning Board. Mrs. Ryder thanked Mr. Sturm for sending this to Rob McEwan for review.

#### **Public Comment**

Bob Barrett asked about Dan Gettel's seat on the Planning Board. Mr. Sturm checked with the Association of Towns and the Attorney for the Town. Mr. Gettel is only a trainee and even when he is appointed as Assessor there is no conflict.

Mark from Woodstock Oasis stated there is an issue with the parking lot at the Bethel Post Office; doing a lot of improvements on the building and ground. Going to pave and stripe the parking lot. Pot holes are 24 feet wide. Can you please try to do something with DOT? Mark called DOT today. Mr. Sturm stated that the Town has had success in the past. We could send a letter. Mark please report back on how you make out with DOT.

## **Adjournment**

There being no further business, Mrs. Ryder moved to adjourn the Town Board meeting. Seconded by Mrs. Hendrickson, put to a vote and carried 5-0. Meeting adjourned at 8:30 p.m.
