Ms. Frangipane suggested that is was not a bad idea to go further; Lumberland should be lead agent. Pine Grove Rd. is the only road in this project. According to DEC, we should send letter to support them as lead agency and for them to notify us of next steps as interested party.

Mrs. Simpson noted that if anyone has an interest, then go to meetings. Town of Bethel does not have to do anything. The Town can comment in the future.

Ms. Frangipane made the following remarks: "Would like to recommend that we, as a board, through the Supervisor, go one step further then to simply "receive & file" this notice. Suggest that we send a letter to the Town of Lumberland acknowledging receipt of their letter and intent to be lead agency. We should wish them the best with this project, which I am sure, will be well done; just as I am sure they will do a thorough review of potential impacts and benefits of the project. What troubles me is that there is nothing compelling them to consider the potential impact which will be involved with utilizing Pine Grove Road as the singular access and these additional 43 homes. I would pose that while the Town of Bethel is not an involved agency...meaning we have no discretionary decision making...we should, in fact, be considered an interested agency-which, under SEQRA, the DEC recommends that agencies disclose ongoing communications with agencies that have regulatory authority over the resources (in this case, a Town Road) and geographic areas that concern them. Even DEC recommends go on record by acknowledging letter and state to be an interested an involved agency. By not responding, you are implying you have no comments."

Mr. Sturm commented that Pine Grove Road is a public road. Anyone can go to public meetings or the public hearing; does not want to intervene on another Town's project. Great project for Lumberland and County; endorsing without reservation.

Motion by Ms. Frangipane to send letter to Lumberland Planning Board acknowledging receipt and to support their lead agency status and to be an interested party to be kept informed of project, seconded by Mr. Cohen, put to a roll call vote with 3 nays and 2 ayes as follows:

- 3. That there shall be audited and allowed and paid to Petitioners by the Town, the County of Sullivan and the Monticello Central School District the amounts, if

any, paid by Petitioners as taxes on the original assessment in excess of what the taxes would have been if said assessment had been made as amended and reduced by this Stipulation. So long as refunds are made by taxing jurisdictions within thirty (30) days of service of the Order implementing the terms of this Stipulation, such refunds may be made without interest. All refunds contemplated by this Stipulation shall be made payable to the order of "Garigliano Law Offices, LLP, as attorneys for Petitioners".

- 4. That an Order implementing the terms of this Stipulation be entered without further notice.
- 5. That upon compliance with the foregoing the above proceedings be discontinued and withdrawn without costs or disbursements by either party against the other.

RESOLUTION OF TOWN BOARD OF THE TOWN OF BETHEL
TO ACCEPT AN ENVIRONMENTAL ASSESSMENT FORM AND PERFORM
CERTAIN OBLIGATIONS UNDER SEQRA PRIOR TO THE ADOPTION OF A
LOCAL LAW TO AMEND CHAPTER 345 "ZONING"
OF THE TOWN CODE OF THE TOWN OF BETHEL

WHEREAS, the Town Board of the Town of Bethel ("Town Board") heretofore adopted a zoning code under the authority of the NY Town Law § 261, which zoning code appears as Chapter 345 of the Town Code of the Town of Bethel (the "Zoning Code"); and

WHEREAS, in 2009 the Town Board introduced Local Law No. 1 of 2009 to amend the Town's Zoning Code, and on January 28, 2009 determined that the proposed action was a type I action under the State Environmental Quality Review Act ("SEQRA"), and established itself as lead agency for SEQRA review purposes; and

WHEREAS, the Town Board, acting as lead agency under SEQRA, completed all of its obligations under SEQRA and adopted a Final Generic Environmental Impact Statement("FGEIS") on June 9, 2009; and

WHEREAS, Local Law No. 1 of 2009, adopting the amendments to the Zoning Code, was enacted on June 24, 2009; and

WHEREAS, on January 25, 2012 the Town Board introduced proposed Local Law No. 1 of 2012 to further amend the Zoning Code, identified the proposed action as a type 1 action under SEQRA, and resolved to appoint itself lead agency for SEQRA review purposes; and

WHEREAS, the resolution of the Town Board introducing proposed Local Law No. 1 of 2012, provided, in part, that (1) the SEQRA materials prepared in support of Local Law No. 1 of 2009 shall be evaluated for recommendation for the necessary scope of SEQRA review for the current action and (2) the appropriate documents for Town Board for review and consideration shall be prepared and delivered to the Town Board; and

WHEREAS, a long form Environmental Assessment Form (the "EAF") has been prepared to review the potential for any significant environmental impacts that may result from the adoption of proposed Local Law No. 1 of 2012; and

WHEREAS, in addition to the EAF, the Town has caused to be prepared a comprehensive local land use analysis titled *Land Use Analysis: Hazardous Or Natural Gas and/or Petroleum Activities & Industrial Uses*, prepared by Greenplan, Inc. for use in review of the proposed local law.

NOW THEREFORE, BE IT RESOLVED, the EAF is accepted as complete and the Town Supervisor is authorized to execute the EAF on behalf of the Town as lead agency; and be it

FURTHER RESOLVED, Part 2 of the EAF does not provide any indication for the potential of a significant environmental impact if proposed Local Law No. 1 of 2012 were to be adopted; and be it

FURTHER RESOLVED, that upon review of the EAF and the SEQRA findings statement adopted for the FGEIS, and as provided by Part 3 of the EAF, said findings statement shall be amended in accordance with 6 NYCRR 617.10(d)(2) to address the following issues: (1) the potential for significant environmental impacts if the proposed zoning amendments are adopted as opposed to the potential for significant environmental impacts if the proposed zoning amendments are not adopted and (2) the potential short term and long term economic impacts if the zoning amendments are adopted; and be it

FURTHER RESOLVED, this Resolution shall become effective when adopted.
