Resolution to Adopt Negative Declaration for Proposed Local Law #3-13

**RESOLUTION OF THE TOWN BOARD OF THE TOWN OF BETHEL
DETERMINING SIGNIFICANCE UNDER SEQRA WITH RESPECT TO AN
AMENDMENT OF CHAPTER 257 “SEWERS” OF THE TOWN CODE OF THE
TOWN OF BETHEL**

WHEREAS, the Town Board of the Town of Bethel (“Town Board”) heretofore adopted Chapter 257 (“Sewers”) of the Town Code of the Town of Bethel (the “Town Code”); and

WHEREAS, the Town Board has determined that revisions to Chapter 257 of the Town Code (“Sewers”) are desirable and necessary and introduced proposed Local Law No. 3 of 2013 to amend portions of said Chapter 257; and

WHEREAS, the Town Board, which declared itself to be lead agency under SEQRA by resolution dated October 16, 2013, determined that the proposed amendment to the Town Code (hereafter, the “action”) is subject to the State Environmental Quality Review Act (ECL, Article 8) and its implementing regulations (6 NYCRR Part 617) (collectively, “SEQRA”); and

WHEREAS, the Town prepared a short Environmental Assessment Form (“EAF”) for the proposed amendment of the Town Code, which EAF has been fully reviewed by the Town Board; and

WHEREAS, upon review of the EAF the Town Board reviewed the thresholds for classifying this action as set forth in 6 NYCRR §§ 617.4 and determined that the action constitutes an Unlisted Action.

NOW THEREFORE, BE IT RESOLVED, that, pursuant to SEQRA, the Town Board of the Town of Bethel, based upon its review of the EAF, makes the determinations set forth below; and be it

FURTHER RESOLVED the Town Board determines that according to its review of the EAF there will be no significant adverse impacts on the environment as measured against the criteria for determining significance under 6 NYCRR § 617.7(c); and be it

FURTHER RESOLVED, this resolution is a Negative Declaration under SEQRA and the information required by 6 NYCRR § 617.12(a) is attached hereto and incorporated herein; and be it

FURTHER RESOLVED, the Town Board hereby directs that a copy of this resolution be filed with (a) the Supervisor of the Town of Bethel, (b) the lead agency, (c) any involved agencies, and (d) any person who has requested a copy; and be it

FURTHER RESOLVED, this Resolution shall become effective when adopted.

**RESOLUTION TO APPROVE A CONTRACT AMENDMENT
FOR THE 2012 – 2015 COUNTY SNOW AND ICE CONTRACT REMOVAL**

The following resolution was duly moved by Lillian Hendrickson, seconded by Denise Frangipane and adopted:

WHEREAS, the County of Sullivan and the Town of Bethel entered into contract for Snow and Ice control on County Roads from July 2, 2012 through June 30, 2015.

WHEREAS, the contract states the Town will be paid the amount Sullivan County received from the State of New York for snow and ice control on state highways the previous snow and ice season; and

WHEREAS, the County of Sullivan was paid the rate of \$5,496.66 per centerline mile for the 2012 – 2013 contract year; and

WHEREAS, said selection of the Highway Law of the State of New York requires the approval by resolution of each of the legislative bodies of such County, Towns;

NOW, THEREFORE, BE IT RESOLVED, that the County of Sullivan pay the amount of \$5,496.66 per centerline mile for two-lane highways and \$8,244.99 for three-lane highways to the Town for the contract year July 1, 2013 – June 30, 2014.

Resolution to adopt for Local Law #3-2013

**RESOLUTION OF TOWN BOARD OF THE TOWN OF BETHEL
ADOPTING A LOCAL LAW TO AMEND CHAPTER 257 “SEWERS”
OF THE TOWN CODE OF THE TOWN OF BETHEL**

WHEREAS, the Town Board of the Town of Bethel (“Town Board”) heretofore adopted a sewer code, which appears as Chapter 257 of the Town Code of the Town of Bethel (“Sewers”); and

WHEREAS, on October 16, 2013, the Town Board introduced Local Law No. 3 of 2013 (a copy of which is attached hereto) to amend the Town Code Chapter 257; and

WHEREAS, on October 16, 2013 the Town Board also determined that the proposed action was subject to review under the State Environmental Quality Review Act (“SEQRA”), and established itself as lead agency for SEQRA review purposes; and

WHEREAS, the Town Board, acting as lead agency under SEQRA, completed all of its obligations under SEQRA and adopted a negative declaration on November 13, 2013; and

WHEREAS, the Town Board provided due notice of a public hearing for Local Law No. 3 of 2013 by publishing timely notice of the public hearing in a newspaper of general circulation in the Town of Bethel; and

WHEREAS, on November 13, 2013, the Town Board conducted a public hearing during which comments were presented and received in connection with the proposed amendment of the Town Code as set forth in Local Law No. 3 of 2013 and upon its conclusion, closed said public hearing; and

WHEREAS, the amendments to Chapter 257 of the Town Code provide for the issuance of a septage permit for the disposal of trucked waste at the Kauneonga Lake Sewer District treatment plant and a copy of the form of permit is attached to this Resolution.

NOW THEREFORE, BE IT RESOLVED, by the Town Board of the Town of Bethel that Local Law No. 3 of 2013, amending Chapter 257 of the Town Code of the Town of Bethel is hereby adopted; and be it

FURTHER RESOLVED, that the form of permit attached to this Resolution is approved for use as a septage permit and said form of permit may be revised from time-to-time upon further Resolution of the Town Board; and be it

FURTHER RESOLVED, this Resolution shall become effective when adopted.

Adopt Resolution to set 2014 sewer user rates

**RESOLUTION OF THE TOWN BOARD OF THE TOWN
OF BETHEL TO ESTABLISH SEWER RENTS FOR THE
KAUNEONGA LAKE CONSOLIDATED SEWER DISTRICT AND
KAUNEONGA LAKE SEWER DISTRICT EXTENSION**

WHEREAS, the Town Board of the Town of Bethel ("Town Board") heretofore adopted Chapter 257 ("Sewers") of the Town Code of the Town of Bethel (the "Town Code"); and

WHEREAS, the Town Board adopted a local law to amend Chapter 257 to provide, among other things, that the sewer rents necessary to provide for the operation and maintenance of and for the payment of debt service for bond obligations for the Kauneonga Lake Sewer District and the Kauneonga Lake Sewer District extension area (together, the "KLSD") may be revised from time to time by resolution of the Town Board; and

WHEREAS, the Town Board, after due notice, conducted a public hearing on October 9, 2013 at which time the public had the opportunity to be heard regarding the proposed amendment of the sewer rents for the KLSD; and

WHEREAS, the Town Board reviewed the thresholds for classifying this action to amend the sewer rents as those thresholds are set forth under the State Environmental Quality Review Act ("SEQRA") in 6 NYCRR § 617.4 and determined that the action constitutes a Type II Action(as set forth at 6 NYCRR §617.5 [20])and no review under SEQRA is required.

NOW THEREFORE, BE IT RESOLVED, that, the Town Board of the Town of Bethel, in accordance with the requirements of Chapter 257 (Sewers) of the Town Code of the Town of Bethel establishes sewer rents for all users located within the KLSD for the calendar year 2014 as follows:

- As set forth in section 257-34(A) of Chapter 257, all Class I, Class II and Class III users located in the Kauneonga Lake Sewer District, with the exception of Class I bungalow users and Class I seasonal users, shall be charged \$427.32 per EDU annually;
- As set forth in section 257-34(A) of Chapter 257, all Class I bungalow users and Class I seasonal users located in the Kauneonga Lake Sewer District shall be charged \$339.92 per EDU annually;
- PAC facility parcels shall be charged capital debt service costs for the Kauneonga Lake Sewer District extension area as computed in accordance with section 257-35(A)(1) of Chapter 257;
- As set forth in section 257-35(A)(2)(a) of Chapter 257, PAC facility parcels assessed at 90 EDUs for 2014, shall be charged \$132.00 per EDU annually for capital debt service costs of Kauneonga Lake Sewer District;
- As set forth in section 257-35(A)(2)(c) of Chapter 257, PAC facility parcels assessed at 105 EDUs, shall be charged \$295.32 per EDU annually for operation and maintenance costs of Kauneonga Lake Sewer District;
- As set forth in sections 257-35(B) and 257(C) of Chapter 257, all Class I, Class II and Class III users located in the Kauneonga Lake Sewer District extension area, with the exception of the PAC facility parcels referenced above and Class I bungalow users and Class I seasonal users, shall be charged \$600.72 per EDU annually;
- As set forth in sections 257-35(B) and 257(C) of Chapter 257, all Class I bungalow users and Class I seasonal users located in the Kauneonga Lake Sewer District extension area shall be charged \$513.32 per EDU annually;
- For any Class III user located in the KLSD which is subject to a cost allocation factor shall pay the sewer rent as calculated pursuant to section 257-34(A)(4) of Chapter 257; and be it

FURTHER RESOLVED, that the sewer rents and service charges established in this Resolution are exclusive of any late payment penalties, fines, charges or costs of collection which may be owed by any user; and be it

FURTHER RESOLVED, this Resolution shall become effective when adopted.

Resolution to Adopt Climate Smart Community Pledge

Mr. Sturm read resolution

***Resolution of the Town of Bethel Town Board to adopt
Climate Smart Community Pledge***

Council member Lillian Hendrickson moved and Council member Denise Frangipane seconded that:

WHEREAS, the Town of Bethel (hereinafter, the “Town” or “we”) believes that climate change poses a real and increasing threat to our local and global environments, which is due primarily to the extraction, production and utilization of fossil fuels;

WHEREAS, we believe that the effects of climate change can endanger our infrastructure, economy, and livelihoods; harm our farms, orchards, and ecological communities, including native fish and wildlife populations; spread invasive species and exotic diseases; reduce drinking water supplies and recreational opportunities; and pose health threats to our citizens;

WHEREAS, we believe that our response to climate change provides us with an unprecedented opportunity to save money while building livable, energy-independent and secure communities, vibrant innovation economies, healthful and safe schools, and resilient infrastructures;

WHEREAS, we believe the scale of greenhouse gas (GHG) emission reductions required for climate stabilization will require sustained and substantial efforts;

WHEREAS, we believe that even if emissions were dramatically reduced today, communities still would be required to adapt to the effects of climate change for decades to come;

WHEREAS, in January 2008, the Town Board unanimously adopted a resolution expressing the Town’s commitment to promote a sustainable future and implement a plan

of action for the development of sustainable practices, including operating Town facilities in a sustainable manner, decreasing energy needs, increasing energy efficiency, and preserving natural resources, peace and tranquility for economic prosperity and the health of future generations;

WHEREAS, to assist in implementing the goals of the aforesaid resolution, the Town Supervisor appointed an advisory committee, whose efforts culminated in a report, “The Bethel Green Initiative,” outlining proposed strategies and policy changes for the long-term economic and ecologic sustainability of Bethel;

WHEREAS, following a New York State Energy Research and Development Authority (“NYSERDA”) audit in April 2008, the Town undertook many of the energy conservation measures recommended as a result of such audit and joined the Municipal Electric and Gas Alliance, all of which were important initial steps in reducing its energy costs; and

WHEREAS, in July 2013, the Town Supervisor designated an advisory committee comprised of local officials and community members to consider the Town’s participation in the NYS Department of Environmental Conservation’s “Climate Smart Communities” initiative, its adoption of this pledge, and additional measures that the Town could take to increase its environmental sustainability and lead the community by example;

NOW THEREFORE BE IT RESOLVED that the Town of Bethel Town Clerk will file a certified copy of this resolution with the New York State Department of Environmental Conservation, Office of Climate Change, 625 Broadway, Eighth Floor, Albany, NY 12233

BE IT FURTHER RESOLVED that the Town of Bethel, in order to reduce greenhouse gas emissions, adapt to a changing climate and reaffirm its commitment to energy conservation and environmental sustainability, will

1. Pledge to Combat Climate Change by Becoming a Climate Smart Community

Set goals to reduce GHG emissions and adapt to predicted climatic changes. Establish a task force of local officials and community members to review the issues and propose a plan of action for consideration by the Town Board. Designate a point person who will oversee climate change initiatives and publicly report on progress. Work cooperatively with similar task forces in neighboring communities to ensure that efforts complement and reinforce one another. As an official signal of commitment and for access to technical resources, sign on to a widespread climate campaign such as the Environmental Protection Agency’s Portfolio Manager or ICLEI Local Governments for Sustainability - Climate Protection (“ICLEI”).

2. Set Goals, Inventory Emissions, Move to Action

Gather data, inventory GHG gas emissions, and establish baselines for local government operations and community sectors. Develop quantifiable interim GHG emission targets consistent with emission reduction goals and propose a schedule and financing strategy to meet them. Encourage stakeholder and public input and develop an action plan. Report emissions to a climate campaign such as The Climate Registry, which has developed a standardized method for reporting emissions inventories; use Portfolio Manager or ICLEI to track and evaluate progress.

3. Decrease Energy Demand for Local Government Operations

Adopt a goal of reducing the Town's energy consumption from 2007 levels by 20% by 2020.

Existing Public Facilities. Inventory current building electricity usage and identify additional opportunities for conservation and efficiency retrofits. Obtain an updated energy assessment from NYSERDA, the New York Power Authority or other professionals. Consider actions such as purchasing energy efficient equipment and appliances, such as ENERGY STAR®; improving lighting, heating, and cooling efficiency; setting thermostats for maximum energy conservation; decreasing plug load from office equipment; and increasing pump efficiency in water and wastewater systems.

New Public Buildings. Achieve the highest practicable U.S. Green Building Council Leadership in Energy and Environmental Design (LEED) certification standards or comparable sustainable principles, practices and technologies for all new local government buildings.

Infrastructure. Incorporate energy efficient technologies and operations and maintenance practices into municipal street lighting, traffic signals, and water and wastewater treatment facilities where practicable.

Vehicle Fleet and Commuting. Improve the average fuel efficiency of local government fleet vehicles. Discourage vehicle idling and encourage bicycling, car-pooling and public transit for employees. Consider reducing the number of vehicles, converting fleet vehicles to sustainable alternative fuels, and using electric vehicles where possible.

4. Encourage Renewable Energy for Local Government Operations

Supply as much of the local government's power, heat and hot water needs as possible from solar, wind, and small hydro through purchase or direct generation.

5. Realize Benefits of Recycling and Other Climate Smart Solid Waste Management Practices

Expand the "reduce, reuse and recycle" approach to waste management in local government operations and in the whole community. Reduce the amount of solid waste generated by promoting backyard composting and educating residents on how to prevent waste. Provide recycling receptacles in local government buildings and outdoor spaces, require duplex printing in government offices, and implement, to the extent feasible, a comprehensive green purchasing program.

6. Promote Climate Protection through Community Land Use Planning

Combat climate change by encouraging low-emissions development that is resilient to climatic changes. When updating land use policies, building codes or community plans continue to advance the goals and objectives of the Town's Comprehensive Plan by including provisions to combat climate change; reduce sprawl; preserve and protect open space, biodiversity, and water supplies; promote compact, transit-oriented, bike able and walkable communities; promote infill development; minimize new development in floodplains and other environmentally sensitive areas; maintain or establish healthy community forests; and promote best forest management practices and encourage tree planting, especially along waterways, to increase shading and to absorb carbon dioxide.

7. Plan for Adaptation to Unavoidable Climate Change

Evaluate risks from unavoidable climate change, set adaptation goals and plan for adaptation. Identify climate change impacts (such as flooding, drought, and extreme temperatures) that could affect the community. Identify areas such as water supply and sewer infrastructure that may be at risk due to sea-level rise and future changes in climate. Factor risks into long-term investments and decision-making. Execute climate

change adaptation and preparedness measures through local government planning, development and operations, giving priority to the highest risk areas.

8. Support a Green Innovation Economy

Identify opportunities to incorporate climate protection, sustainability and environmental goods and service industries into economic development plans. Encourage workforce development training and school curricula that support the emerging green collar job sector, including renewable energy and energy efficiency, as well as climate smart solid waste management practices. Procure climate smart goods and services for local government operations as may be feasible and in compliance with applicable laws and policies. Support modernizing of local and national electricity grids.

9. Inform and Inspire the Public

Lead by example. Highlight local government commitment to reducing energy use, saving tax dollars, and adapting to changing conditions. Demonstrate the benefits of energy savings, energy efficiency, and renewable energy projects by hosting open houses; distributing fliers; holding local meetings; working with school districts, colleges, and universities to develop climate change curricula and programs; engaging faith-based communities in climate protection; and regularly communicating community climate protection goals and progress to constituents.

10. Commit to an Evolving Process

Acknowledge that research and policy on climate protection are constantly improving and evolving. Be willing to consider new ideas and commit to update plans and policies as needed. Compare successes, cooperate and collaborate with neighboring communities to redirect less-effective actions and amplify positive results.
