## **Bond Resolution for the purchase of equipment**

A RESOLUTION AUTHORIZING THE PURCHASE OF HEAVY EQUIPMENT FOR THE TOWN OF BETHEL, SULLIVAN COUNTY, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$410,821.33, AND AUTHORIZING THE ISSUANCE OF \$410,821.33 BONDS OF SAID TOWN TO PAY THE COST THEREOF

The following resolution was offered by Lillian Hendrickson, who moved its adoption, seconded by Bernard Cohen, to-wit:

BE IT RESOLVED, by the affirmative vote of not less than two-thirds of the total voting strength of the Town of Bethel, Sullivan County, New York, as follows:

- <u>Section 1.</u> The purchase of heavy equipment for the Town of Bethel, Sullivan County, New York, is hereby authorized at a maximum estimated cost of \$410,821.33.
- <u>Section 2.</u> The plan for the financing of such maximum estimated cost shall be by the issuance of \$410,821.33 bonds of said Town hereby authorized to be issued therefor pursuant to the provisions of the Local Finance Law.
- Section 3. It is hereby determined that the period of probable usefulness of the aforesaid class of objects or purposes is five years, pursuant to subdivision 28 of paragraph a of Section 11.00 of the Local Finance Law. It is hereby further determined that the maximum maturity of the bonds herein authorized will not exceed five years.
- Section 4 The faith and credit of said Town of Bethel, Sullivan County, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. There shall annually be levied on all the taxable real property of said Town, a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.
- <u>Section 5.</u> Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of such notes, is hereby delegated to the Supervisor, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Supervisor, consistent with the provisions of the Local Finance Law.
- Section 6. All other matters except as provided herein relating to the serial bonds herein authorized including the date, denominations, maturities and interest payment dates, within the limitations prescribed herein and the manner of execution of the same, including the consolidation with other issues, and also the ability to issue serial bonds with substantially level or declining annual debt service, shall be determined by the Supervisor, the chief fiscal officer of such Town. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law, and shall otherwise be in such form and contain such recitals, in addition to those required by Section 51.00 of the Local Finance Law, as the Supervisor shall determine consistent with the provisions of the Local Finance Law.

Section 7 The validity of such bonds and bond anticipation notes may be contested only if:

- 1) Such obligations are authorized for an object or purpose for which said Town is not authorized to expend money, or
- 2) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

3) Such obligations are authorized in violation of the provisions of the Constitution.

<u>Section 8.</u> This resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150 - 2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.

Section 9 This resolution, which takes effect immediately, shall be published in summary form in the official newspaper of said Town designated for such purpose, together with a notice of the Town Clerk in substantially the form provided in Section 81.00 of the Local Finance Law.

# Resolution of the Town of Bethel Town Board to adopt the Complete Streets Program Policy

**WHEREAS,** Complete Streets are streets that provide safe, comfortable, and convenient access for users of all ages, abilities and all modes of transportation including pedestrians, bicyclist, motorist, and transit riders; and

**WHEREAS**, the Town of Bethel Complete Street vision is to encourage the development of a complete street network throughout the Town to create a more balanced transportation system; and

WHEREAS, Complete Streets design features and practices include, but not limited to, sidewalks, paved shoulders suitable for cycling, designed bike lanes, lane stripping, shared road signage, crosswalks, curb ramps, audible pedestrian signals, pedestrian crossing signage, traffic calming measures such as curb bump-outs, center islands and pavement markings; and

**WHEREAS**, the Town of Bethel recognizes that this Complete Street Policy also includes the incorporation of this community's values and as such will be mindful of its environment, scenic, aesthetic, historic and natural resources in any such design and planning: and,

**WHEREAS**, Complete Streets improves rates of physical activity and related outcomes, neighborhood vitality, social interaction and supports economic development by helping to create a walkable, vibrant Town where businesses can thrive while also supporting livable neighborhoods; and

**WHEREAS**, the Complete Streets Program outlines an approach to for an improved, transparent process to promoting shared access throughout the community while increasing the capacity and efficiency of road network, improve traffic calming by improving transportation options and limit greenhouse gas emissions; and

**WHEREAS**, the Complete Streets Program encourages incorporating complete streets design practices, to the extent feasible, as a part of routine infrastructure planning, design, and maintenance for public and private projects; and

**WHEREAS**, the Complete Streets Program consistent with and assist in achieving the goals and recommendations set forth in the Town's Comprehensive Plan and other adopted policy documents; and

**WHEREAS,** New York State passed the complete streets law in 2011 that requires that complete streets design guidelines be considered for the planning, design, construction and reconstruction of roadways receiving federal and state funding; and

**WHEREAS**, the people of the Town of Bethel have expressed support for Complete Streets, and

**NOW, THEREFORE BE IT RESOLVED** that the Town Board of Bethel herby adopts the Complete Streets Program Policy to enhance shared access within the Town of Bethel and to improve quality of life for its residents; and

**NOW, THEREFORE BE IT FURTHER RESOLVED** that the Town of Bethel will strive to initiate the recommended action items in the immediate future, including the establishment of a Complete Street Checklist.
